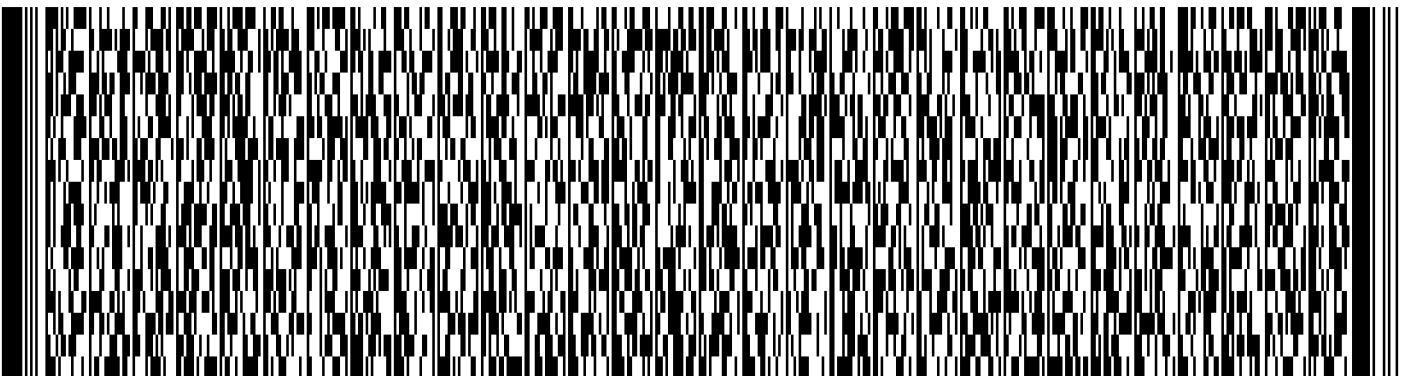


Bankruptcy1to50



Bankruptcy51to100

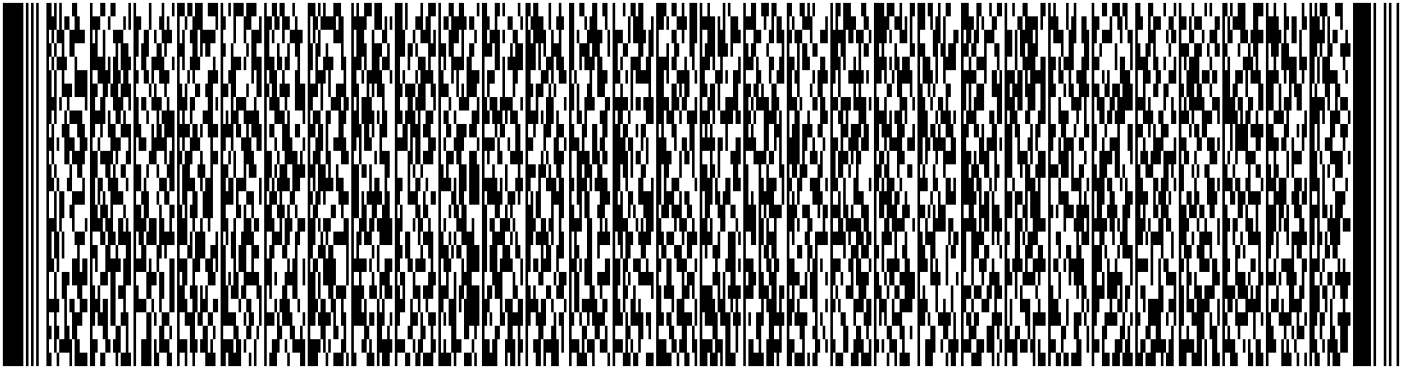

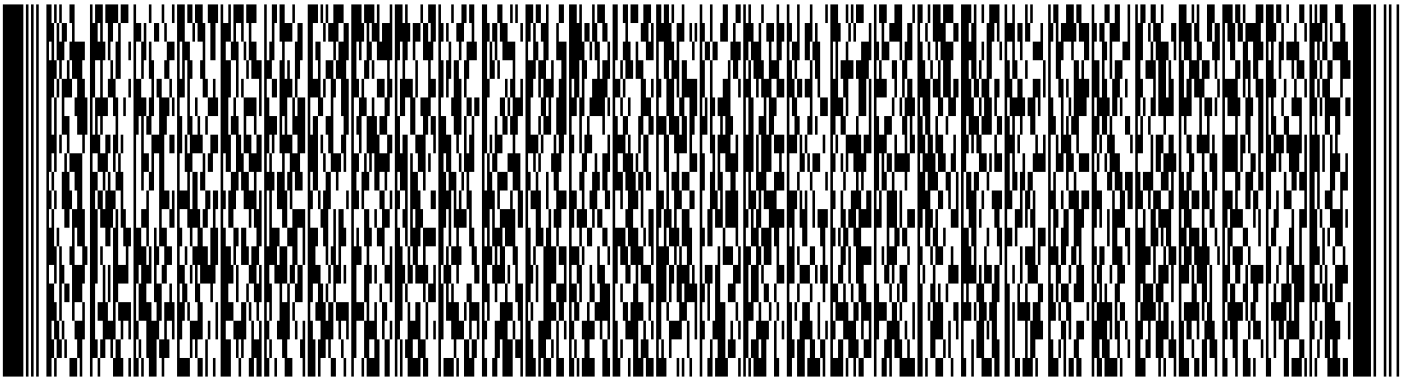
