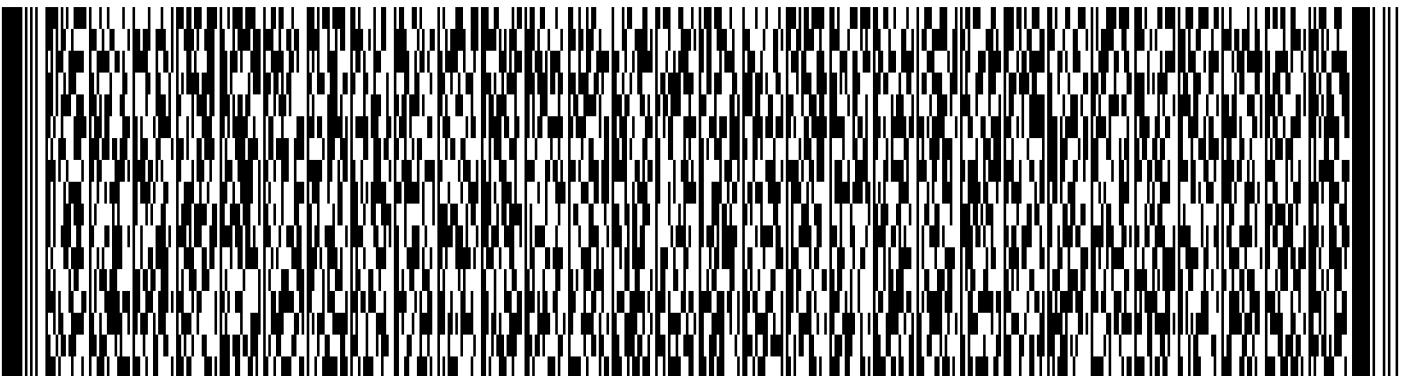


Bankruptcy1to50

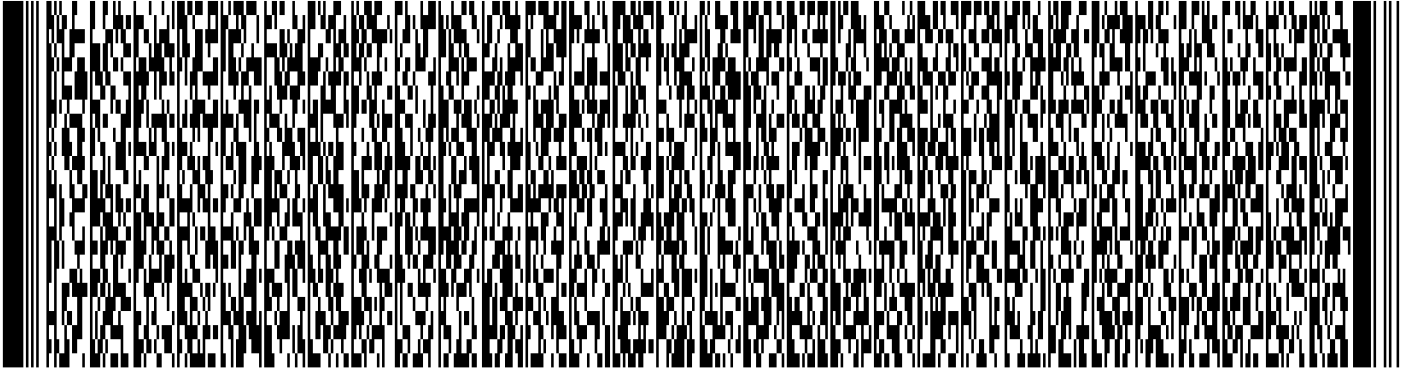

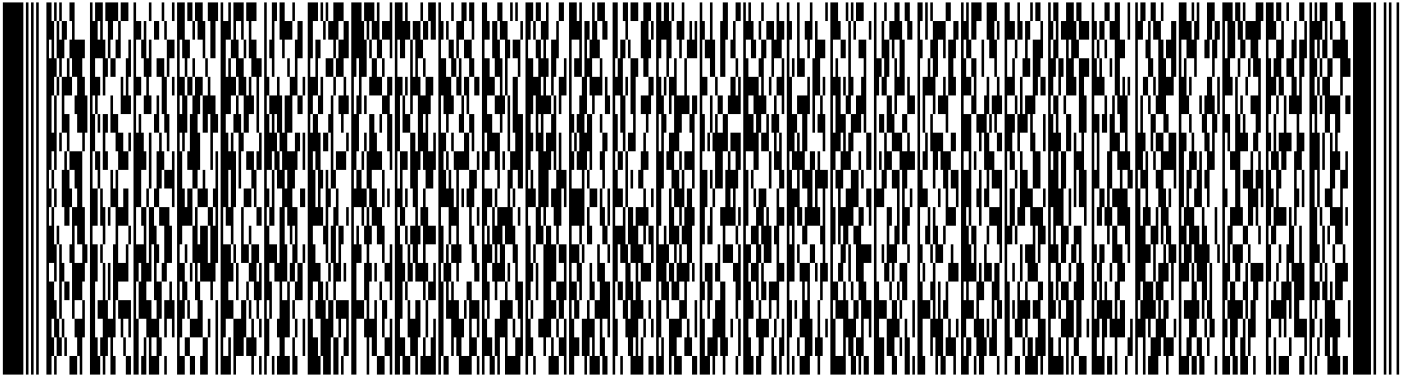
