

<sup>(2)</sup> To date, the Plan Administrator has, among other things, sold real estate, negotiated loan terms, monetized the performing loans in the Debtor's loan portfolio, and resolved certain litigation. The Plan Administrator believes, in his business judgment, that the projected date for the entry of a final decree in this case is subject to, among other things, the following events: (i) the conclusion of any litigation around the United States that is seeking or may seek to recover monies on behalf of the estate; (ii) the monetization of the unsold loan portfolio; and (iii) the reconciliation of claims. Based on the facts available at this time, the Plan Administrator believes that the date of the entry of the final decree may be on or before September 30, 2020; however, the actual date of the entry of the final decree may be later than this date.
